All center court areas that charge a fee for their services will now be charged for their space. Everyone will pay the same fee, but areas will differ in size dependent on the activity.

Residency: Only Pennsylvania resident Artisans may participate in the People's Choice Festival!

Application form: Fill out the application completely and postmarked by April 15th. All information and enclosures are required to be considered for the jury process.

CD: Slides and digital photos are no longer accepted. All new applicants must submit a CD with the required 3 product images and one booth image. *Returning applicants have CD's on file.*

Rules & Regulations: For your benefit review the accompanying Rules & Regulations.

Acceptance: We will notify you by MAY 15th accepted or not. There are absolutely NO REFUNDS.

Payment: Enclose checks payable to "People's Choice Festival" as follows: (1) One postdated check dated April 15, 2017 for the nonrefundable \$25 processing fee; (2) one postdated check dated April 15, 2017, for your regular booth fees.

PARTICIPANTS - RULES & REGULATIONS

Check-In

- Check in and set up is Wednesday between 9:00 am and 6:30 pm. We reserve the right to replace participants who do not set up Wednesday with standby Artisans.
- You will be escorted to your site by a festival representative.

Display

- Participants must provide the activity listed on the Application. The Festival representatives may reject non-complying participants.
- Participants agree not participate in any other festival or craft show within a 25-mile radius of the People's Choice Festival during the dates of the show.
- The Festival does not have electrical hookups or water available for participants.
- Generators are permitted only with special permission from the festival committee.
- **SIGNS**. Attach all signs to your booth. The Festival does not permit freestanding or staked signs anywhere on the Festival grounds.
- You are not permitted to camp in your vehicle or booth. Camping arrangements must be made with the Museum. Contact: **Ann Carras @pmmfriendsbusmgr@gmail.com**
- Participants will leave their site in the same condition as when they first arrived. Place all trash in provided receptacles (dumpsters) before leaving the grounds.
- **Participants may not have pets on the festival grounds.** No OPEN FLAMES permitted.

Parking

- All vehicles must be parked behind the Military Museum. Parking permits are available on Wednesday at check-in.

Application

- Only Pennsylvania resident Artisans are eligible to participate in the Festival. The application must list each owner, partner or shareholder of the business.
- Please read the application carefully. Complete all information. Print clearly. Check box or boxes and send the appropriate checks. Separate checks are required for the application fee and booth fee. Sign and date the application. **Mail by the April 15th deadline.**
- Acceptance is for the current year's Festival only, and is not automatically renewable for any future year's Festival. The acceptance of an Artisan to the Festival is nontransferable. If an Artisan sells his or her business, the new owner must reapply.
- Artisans should request Delivery Confirmation from the postal service if they want confirmation of receipt of their application. Please do not c Festival representatives asking if your application was received.
