We will not issue refunds for any reason for cancellations postmarked after March 15<sup>th</sup>.

#### WINERY RULES & REGULATIONS:

- Only Pennsylvania residents are eligible to participate in the Festival. You <u>MUST</u> grow, produce or manufacture in the state of Pennsylvania, the products you offer for sale.
- Acceptance is for the current year's Festival only, and is not automatically renewable for any future year's Festival.
- After mailing your application, <u>if you</u> determine you <u>cannot participate</u> in the show, <u>YOU</u>
  <u>MUST</u> notify us by MARCH 15th. We will not issue refunds for any reason after that date.
- Vendors must comply with all local, state and Pennsylvania Liquor Control Board Rules and Regulations.
- Vendors must carry Product Liability Insurance. Vendors must have their insurance agent mail a copy of the Certificate of Insurance directly to the Festival's mailing address listed below. The Policy must list all owners, partners, or shareholders and the business d/b/a name (if applicable).
- Vendors must submit Pennsylvania Liquor Control Board Permit, Sales Tax Number and Certificate of Insurance as required by the Pennsylvania Military Museum. Please mail the PLCB permit when available to the People's Choice Committee. Please submit the sales ta and insurance paperwork with your application.
- Vendors may only sell wine and winery related items as described on your original application.
- □ Acceptance of a vendor to the Festival is non-transferable.
- □ Vendors may not share their space with any other parties.
- □ Sales Area The additional 10' in depth is allocated specifically for stock not sales.
- □ Re-stocking must be done before 9:30 am or after 8:00 pm. Vehicles must be off the grounds by 9:30 am and may not re-enter until 8:00 pm.
- Vendors will leave their site in the same condition as when they first arrived. Vendors must remove cardboard and bottles and deposit them in the proper recyclable receptacles daily. They are located behind food the Food Court. The PCF Committee will monitor all trash removal. Please help us keep additional pick-up and transportation fees of refuse at a minimum.
- □ The Festival does not permit the use of generators.
- Signage Attach all signs to your booth. The Festival does not permit freestanding or staked signs anywhere on the Festival site.
