<u>Only</u> Pennsylvania residents are eligible to participate in the Festival. You <u>MUST</u> grow, produce or manufacture in the state of Pennsylvania, the products you offer for sale.
Acceptance is for the current year's Festival only, and is not automatically renewable for any future year's Festival.
Vendors must comply with all local and state food handling codes.
Vendors must carry Product Liability Insurance. Vendors must have their insurance agent mail a copy of the Certificate of Insurance directly to the Festival's mailing address listed below. The Policy must list all owners, partners, or shareholders and the business d/b/a name (if applicable).
Vendors may only sell items that are described on your original application.
Acceptance of a vendor to the Festival is non-transferable.
Vendors may not share their space with any other parties.
<u>Your Space</u> : Please keep in mind you are sharing the tent with 11 other vendors, please respect their space. Your enthusiasm is appreciated, but not when it overpowers others' sales efforts.
After mailing your application, <u>if you</u> determine you <u>cannot participate</u> in the show, <u>YOU</u> <u>MUST</u> notify us by MARCH 15th. We will not issue refunds for any reason after THAT DATE
Sales Area – The Specialty Food Vendors Tent is shared by all Vendors under one large tent. The Tent will be divided into the appropriate number of 10' x 10' corner booth spaces. Please work with your neighbor and respect each other's areas. Please police and keep the area presentable at all times, and clean up and dispose of all trash into the Dumpsters located behind the Main Food Court prior to leaving you area at the end of the Festival.
Vendors will leave their site in the same condition as when they first arrived.
The Festival does not permit the use of generators.
Signage - Attach all signs to your booth. The Festival does not permit freestanding or staked signs anywhere on the Festival site.
