Processing Fee: \$ 25.00 Separate Check

Electrical Fee: \$ 1.00 \$1 Per Amp (20 amp = \$20.00 etc.)

Late Fee: \$ 25.00 Apply if mailed after February 1st Separate Check

Booth Fees: \$ 70.00/ft Fee is based on front footage, this included flaps and tongue if

applicable. Minimum space is 15 feet. CORRECT MEASUREMENT IS CRUCIAL!!

Residency: Only Pennsylvania residents may participate as vendors in the People's Choice Festival!

<u>Application form</u>: <u>RETURNING VENDORS</u>: <u>PLEASE use the THIS application mailed</u>. These applications contain all your current information as it appears in our files. Make changes if needed. <u>NEW VENDORS</u>: Fill out the Application completely and mail it by **February 1**st. If you do not include all the required information, your application will not be accepted!

Rules & Regulations: Review the accompanying Rules & Regulations. There is a separate Utilities Addendum which also includes supplementary information. You need to understand these.

<u>Liability Insurance</u>: It is the responsibility of the People's Choice Festival to collect the Certificate of Liability for each vendor in the amount of \$1,000,000. The Certificate Holder or Additional Insured section must list the following: <u>Centre County Grange Encampment & Fair, 169 Homan Lane, P.O. Box 271, Centre Hall, PA 16828</u> and <u>The People's Choice Festival, P.O. Box 407, Pine Grove Mills, PA 16868</u>. All Vendor Certificates of Insurance must be received at the Peoples Choice Festival by <u>June 1, 2025</u>. Please email to <u>peopleschoicefestival@gmail.com</u>.

<u>Acceptance</u>: We will notify you by March 15th, of your acceptance status. If, after mailing your application, you determine you cannot participate in the show. <u>YOU MUST</u> notify us in writing by **March 1**st, to receive a refund. We will <u>not issue refunds</u> for any reason after March 1st.

Payment: Enclose all three (3) checks payable to "People's Choice Festival".

FOOD VENDOR RULES & REGULATIONS

- 1. **Eligibility**: Only Pennsylvania residents are eligible to participate in the Peoples Choice Festival.
- 2. **Acceptance**: Vendor's acceptance is for the current year's Festival only and is not automatically renewable. Food vendors must comply with all local and state food handling codes.
 - The festival's acceptance of your application is non-transferable. If a vendor sells his or her business, the new owner must re-apply.
- 3. <u>Set-Up</u>: Set-up is Wednesday 7/9 before 5:00 pm. Vendors, please enter Gate 4. You will be escorted to the food court.
 - Booth placement is at the discretion of the Food Court Director and may differ year to year.
- 4. **SIGNS**. All signs must be within your paid booth space. The festival does not permit freestanding, staked or sandwich board signage on the Festival grounds.
- 5. **Parking**: Each food concession is permitted to have their "trailer" and "one stock trailer" in their assigned space. For some of you, your stock trailer is your vehicle, and if your space allows you may park behind your booth. There will be parking available directly behind the food court.
 - The Festival committee reserves the right to have any vehicle towed at their discretion.
- 6. **Product**: Each vendor is permitted to have for sale six (6) individual food items. Drinks and sides are not included in that count but lemonade and orange aide are sold only at Drink Booths.
 - Please come prepared with all stock needed for the day. After parking, you are not permitted to move that vehicle between the hours of 9:30 am and 8:00 pm Thursday -Saturday, and 11:30 am and 5:00 pm on Sunday,
- 7. <u>Utilities</u>: See the Utilities Addendum which is an integral part of these Rules & Regulations. The use of individual generators by vendors is not permitted.
- 8. Trash removal **is the responsibility of each individual vendor**. Please break down cardboard boxes and place them in the provided recyclable container. All other trash should be bagged and placed in the provided dumpster.
- 9. Dirty water can be disposed of in the gray water tanks provided by the festival.
- 10. It is your responsibility to properly store and dispose of fryer grease off-premises.
- 11. Insurance: The People's Choice Festival will collect the Certificate of Liability for each vendor in the amount of \$1,000,000. The Certificate Holder or Additional Insured section must list the following: Centre County Grange Encampment & Fair, 169 Homan Lane, P.O. Box 271, Centre Hall, PA 16828 and The People's Choice Festival, P.O. Box 407, Pine Grove Mills, PA 16868. All Vendor and Artisan Certificates of Insurance must be received at All Certificates of Liability must be received at the Peoples Choice Festival (address above) by June 1, 2022.

RETAIN FOR REFERENCE

ELECTRICITY: General requirements

- 1. Electrical power is available to those vendors who require it.
- Each vendor must provide their own electrical supplies and equipment for service.
 Please come prepared with one of the following. A limited number of plugs will be available for sale if needed.
 - a. 30 amp/120v
 - b. 50 or 60 amp/220v
 - c. 120 amp/20 v
- 3. Vendors may not perform their own hookups.
- 4. Only authorized Festival Representative(s) or the Professional Electrician(s) hired by the festival may perform grid or vendor system hookups. Contact the Food Court Director, Rick Snyder, after you have set up your trailer or booth and are ready for service,
- 5. The Festival Representatives will meter each vendor's current load to balance the overall grid usage.
- 6. The Food Court Director, at his sole discretion, may map any grid, vendor system wires or cables for safety reasons.
- 7. Festival Representatives will strictly enforce all principles listed in this Addendum. These provisions are non-negotiable. We have the responsibility of creating a safe environment for all vendors and the attending public. Therefore, the Festival representatives reserve the right to: (1) immediately expel any vendor who violates any of these principles and (2) hold the vendor responsible for any injury or damage due to their actions.
- 8. Contact Rick if you experience any problems during the festival. Do not attempt any repairs to the main service or hookups. If you do, you will not be included in the festival next year!
